

1. Pursuant to article 428. Capital Markets Act, Medika d.d., Zagreb, Capraška 1 (hereafter: the Issuer) announces that on 17 May 2010 has received notification from company Mavota d.o.o., Zagreb, Teslina 12, based on which the company pursuant to article 413. and 417. of Capital Markets Act, notifies the Issuer on the change in the percentage of voting rights. From the mentioned notification arises that Mavota d.o.o., Zagreb, Teslina 12, MBS:080447461, OIB: 69117261543, represented by authorised person – director Mate Perković, as at 12 May 2010 has signed the Contract on sale and transfer on shares, by which the company acquired 60 shares of the Issuer, ticker MDKA-R-A, the Contract on sale and transfer on shares by which the company acquired 70 shares of the Issuer, and the Contract on selling shares and agreement on joint acting with Pliva d.d., Prilaz Baruna Filipovića 25, OIB: 35396788865, Medika d.d. Zagreb, Capraška 1, OIB: 94818858923, and Delo prodaja d.d. from Ljubljana, Dunajska 5, Republic of Slovenia, by which, among other things, is agreed acquisition of 2,800 shares of the Issuer, and after mentioned acquisitions Mavota d.o.o. holds 10,078 shares of the Issuer which represents 33.38% of share capital, actually 35.06% of voting rights, given the fact that the Issuer holds 1,452 treasury shares. Furthermore, in accordance with article 417. paragraph 1, point 1 of Capital Markets Act, Mavota d.o.o. has notified the Issuer that together with companies Pliva d.d. and Medika d.d., based on the Contract on selling shares and agreement on joint acting, jointly holds in total 19,152 shares, which represents 63.43% of total number of shares of the Issuer. Since the Issuer holds 1,452 treasury shares with dormant rights, Mavota d.o.o. and persons with whom jointly acts based on the contract hold 61.58% of total voting rights of the Issuer.
2. The Issuer on 17 May 2010 has received notification from Delo Prodaja d.d. Ljubljana by which the mentioned company pursuant to article 413. of Capital Markets Act, notifies the Issuer that on 12 May 2010 had signed the Contract on selling shares and agreement on joint acting with Pliva d.d., Prilaz Baruna Filipovića 25, OIB: 35396788865, Medika d.d. Zagreb, Capraška 1, OIB: 94818858923 and Mavota d.o.o. Zagreb, Teslina 12, Republic of Croatia, OIB: 69117261543, by which 2,800 shares of the Issuer were sold, representing 9.27% of share capital and 9.74% of voting rights in the Issuer since the Issuer holds 1,452 treasury shares. The company has fallen under the level of 5% of the voting rights, that is, after the mentioned release of the shares, Delo prodaja d.d. no longer holds shares of the Issuer.
3. The Issuer has also received on 18 May 2010 notification from Pliva d.d. Zagreb, Prilaz baruna Filipovića 25, by which the mentioned company pursuant to article 413. of Capital Markets Act, notifies the Issuer that on 12 May 2010 had signed the Contract on selling shares and agreement on joint acting with Mavota d.o.o. Zagreb, Teslina 12, Republic of Croatia, OIB: 69117261543, Medika d.d. Zagreb, Capraška 1, OIB: 94818858923 and Delo prodaja d.d. from Ljubljana, Dunajska 5, Republic of Slovenia, and further on, in accordance with article 417., paragraph 1, point 1 of Capital Markets Act, Pliva d.d. has informed the Issuer that together with the companies Mavota d.o.o. and Medika d.d., based on the Contract on selling shares and agreement on joint acting, jointly holds in total 19,152 shares, which represents 63.43% of total number of shares of the Issuer. Since the Issuer holds 1,452 treasury shares with dormant rights, Pliva d.d. and persons with whom jointly acts based on the contract hold 61.58% of total voting rights of the Issuer.
